2017 PROSPECTUS

New Mexico Veterans Art is a 501(c)(3) non-profit organization staffed and organized by volunteer veterans for the purpose of promoting the talents of military personnel, past and present, and their spouses.

ELIGIBILITY

All veterans, active duty, National Guard, Reserve forces along with their spouses/partners are eligible to submit entries to be juried into the New Mexico Veterans Art Show. Any questions regarding eligibility will be resolved through evaluation of the service member’s DD Form 214 or other proof of service.

STANDARDS OF SUBMISSION

Only work submitted in accordance with the “SCHEDULE OF ACTIVITIES” section of this prospectus will be accepted.

Entries must have been completed within two years of entry date and must be available for sale. The applicant must have been solely responsible for the artistic creation of entries submitted. No reproductions, copies, kits or manufactured items will be accepted.

An applicant may enter up to three pieces per category and may enter more than one category provided that a separate application form is completed for each category entered. Additional copies of the APPLICATION FOR ENTRY form attached to this prospectus may be reproduced as needed.

NMVA reserves the right to determine the acceptability and the category of each entry submitted. NO entry will be accepted which can be considered to be offensive to any racial, religious or gender group. This limitation should not be construed as censorship, but rather as respect for all entrants and patrons viewing the show.

SUBMISSION OF ENTRIES

Although applicants are encouraged to hand-deliver entries to the show site, entries may be shipped.

All entries must be ready for display at time of delivery. Hanging art must be ready to hang with the apex of the wire 3 inches from top of frame. Pedestals and display cases will be available, but an applicant may provide their own as long as it is compatible with the overall display standards of the show.

Hand delivered entries must be delivered to the show site on the date and time cited in the "SCHEDULE OF ACTIVITIES" section of this prospectus.

All items received must include an appropriate entry form and all necessary fees. Fees should be in the form of check or postal money order. Cash will only be accepted for hand delivered entries.

Entries must be professionally packed and shipped with appropriate amount of insurance coverage. A PRE-PAID RETURN SHIPPING LABEL must be included for return shipment of entries.

NMVA and its agents accept no responsibility for damages caused during shipping and handling of entries. Framed artwork that is shipped must utilize an acrylic (Plexiglas) covering. DO NOT SHIP A FRAMED ITEM WITH A GLASS COVERING.

Entries received will be unpacked and inspected for damage. Any damage that occurred during shipment will be reported to the entrant. Entries will be repacked at the end of the show utilizing original shipping materials. Entries will be return shipped within two weeks following close of show.

ENTRY FEES AND DONATIONS

All entrants must become members of NMVA. Membership dues are \$25.00 annually and may be paid at time of entry. Annual membership period is from November thru October. Benefits of membership include notification of special events and opportunities offered to NMVA members, notification of quarterly membership meetings and receipt of quarterly newsletter, as well as discounts at certain art suppliers.

An applicant may enter up to three pieces in any single category and may enter multiple categories. Entries may be submitted in any category for a fee of \$10 per single entry or \$25 for three entries in the same category. Entries must be accompanied by an APPLICATION FOR ENTRY form for each category entered.

Each entrant agrees to donate 25% of any sale made during the show to NMVA.

LIABILITIES AND RESPONSIBILITIES

NMVA volunteers will make every effort to protect all artwork entered in the show. NMVA and its volunteers cannot be held liable for any damage or loss which may occur. Each entrant is expected to have adequate insurance coverage to cover any loss or damage incurred.

Sales taxes will be collected for all competitive artwork sold during the show and remitted to the NM Dept. of Tax & Revenue.

EACH ENTRANT IS RESPONSIBLE FOR DELIVERY/PICK-UP OF ALL ENTRIES SUBMITTED. NMVA shall not be responsible for any entry not picked up during the scheduled pick-up time/date. NMVA has no ability to store any item which the entrant fails to pick up.

ENTRIES NOT PICKED-UP DURING DESIGNATED DATE/TIME WILL BE DISPOSED OF AT THE DISCRETION OF NMVA'S BOARD OF DIRECTORS.

AWARDS

Category-specific award ribbons will be presented to award recipients during Opening/Awards Ceremonies. Certain awards will be accompanied by a cash value award.

Cash value awards may include:

Best of Show Award	\$100
Patriots Award	\$50
NMVA 1 st Place Award	\$75
NMVA 2 nd Place Award	\$50
NMVA 3 rd Place Award	\$25

Merit Awards – are selected and presented by representatives of various organizations, corporations or individuals sponsoring the specific award. Merit awards may have an accompanying cash value for the recipient.

RIBBONS

NMVA will present First, Second and Third Place ribbons in each category for which there are qualified entries.

At the discretion of NMVA’s Board of Directors, a reduced number of awards may be presented in any category for which there are three or fewer entrants.

SILENT AUCTION

A Silent Auction, which serves as the primary fund-raiser for NMVA, is conducted during the show. Each entrant is encouraged to donate one or more items for the auction. Donations received will be displayed during the entire period of the show. All visitors are encouraged to bid on the donated items. A “minimum bid” is established for each item donated. Amount of this bid may be established by the artist or by an NMVA official in the absence of an artist-designated minimum bid. A “BUY NOW BID” shall be established for each item so that the item may be purchased immediately irrespective of any other bids. Any item which does not

receive the minimum bid will be retained by NMVA for use in other auctions/activities in support of NMVA.

All funds received from the auction are used to support official NMVA activities. The value of each item donated is tax deductible for the artist. NMVA will provide a record of the donation to support personal tax deduction, if requested.

Individuals wishing to donate should complete the SILENT AUCTION DONATION form which is attached to this prospectus. This form will be signed by the President of NMVA and returned to the artist after the sale of donated item has been completed, if requested.

NO EXCEPTIONS

SHOW CATEGORIES

Each entry submitted shall be classified in one of the following categories. NMVA reserves the right to reclassify any entry into the appropriate category if, in the opinion of the juror or judges, the item has been misclassified. In such a case the artist shall be notified.

01 - OIL PAINTING: Two-dimensional works in oil or enamel

02 - ACRYLIC PAINTING: Two-dimensional works in acrylics

03 – WATER BASED MEDIA: Two-dimensional works in water based pigment

04 - PRINTS: Printed art created by hand etching/carving the surface of wood, metal, vinyl, plastic, stone or silk screening

05 - DRAWING: Original works created with pencil, charcoal or similar drawing media on any surface

06 - PASTEL DRAWING: Works produced on paper or other media using recognized pastel drawing techniques

07 - INK: Liquid ink pigment applied by pen or brush on any surface

08 - PHOTOGRAPHY: Any image initially captured through the use of a camera. Images may be produced by chemical or digital process, in color or black and white, and may be enhanced through mechanical and/or computer technology

09 - DIGITAL ART: Any image whose total creation required the use of computer-based tools to create the final image

10 - SCULPTURE: Three-dimensional works in metal, stone, wood, resin, or other material

11 - GLASS: Functional or decorative original art, not jewelry, created by the use of glass (i.e. stained glass, hand blown or fused)

12 - FIBER: Original wearable or decorative works created on or with fiber

13 - LEATHER: Any works created on or with leather

14 - CERAMICS: Decorative or functional

15 - JEWELRY: Designed and created solely by the artist

16 - WOODWORK: Original furniture, scroll saw, or carving

17 - MIXED-MEDIA: Any combination of two or more media

18 - COLLABORATIVE ART: Created by two or more individual artists
